2019-20 DUAL ENROLLMENT FOR THE WATERFORD SCHOOL DISTRICT
VERIFICATION OF ELIGIBILITY FOR DUAL ENROLLMENT

This letter is to verify that _____ meets the conditions outlined in Public Act 160, Section 21b, Postsecondary Enrollment Options Act, and Public Act 258 and is eligible for postsecondary enrollment based on the following criteria:

The student must:

- Be in grades 9 through 12 and be enrolled in at least one (1) high school course in the Waterford School District. To receive tuition reimbursement, the number of high school classes and postsecondary classes cannot exceed a total of seven (classes).
- Take Postsecondary courses during the academic school year.
- Meet State of Michigan eligibility requirements.
- Not enroll in college courses such as a hobby, craft, or recreation course, or in the subject areas of physical education, theology, divinity, or religious education.
- Understand they cannot take a replacement course at the high school if they withdraw from the college course.
- Understand credit for the course taken during the semester is .5 high school credit.
- Provide their own transportation to and from the postsecondary school.
- Reimburse the Waterford School District for all costs if the course is failed or dropped after the official withdrawal period.

It is understood that your institution will send a written notice to our district and to the student indicating the course or courses and hours of enrollment. Your notice to the student will also include the amount of the tuition, materials, fees, books, and any other related charges. It is also understood that following the drop/add period, you will submit a bill to our district detailing the tuition and fees for this student.

School districts are required to pay an amount equal to the prorated percentage of the statewide pupil weighted average foundation allowance, based on the proportion of the school year that the eligible student attends the eligible postsecondary institution. Eligible charges include tuition and mandatory course fees, material fees, and registration fees required by an eligible institution for enrollment in the course. *Eligible charges do not include transportation or parking costs or activity fees.*
