For the results from the 2017-18 school year, our school has not received a designation.

Our goal is to continue to be a school that our community can be proud of. We continue our progress by providing individualized instruction and utilizing student performance data from standardized tests, local assessments and NWEA MAP results. We have structured our intervention classes to meet the needs of different levels of learners as to target individual student needs in relation to Math and Reading We also offer a growing list of accelerated classes that focuses on providing advanced learning and high school credit opportunities. Our school improvement team spends many hours creating goals and action plans for addressing the challenges we face

with student achievement. Closing Mason's achievement gap is essential to our success. We are committed to differentiated programming and instruction to meet the unique needs of all our learners.

In the Waterford School District, students are assigned to a school based on their home residence. Parents who wish to have their child(ren) attend a school other than their home school can request that option through our school selection process. Children's Village School services children who have been adjudicated there through the court system. Students are assigned to Kingsley Montgomery School from around the county through an Individual Educational Plan process.

Mason Middle School will focus on the following school improvement goals:

1. All students will increase math proficiency.
2. All students will increase reading proficiency.
3. All students will increase writing proficiency.
4. All students will be engaged in their education and be confident in their ability to be successful.

It was implemented in alignment with the State of Michigan which has a comprehensive curriculum for all grade levels. There are no variances from the state's model.

Kingsley Montgomery School (KMS), is a special education facility that provides support for severe cognitive impaired (SCI), severe multiply impaired (SXI) and severe emotionally impaired (SEI) students. Kingsley Montgomery School currently provides center-based support for SXI and SCI students who are 3 to 18 years of age.

Children's Village School is a North Central Association accredited facility owned by Oakland County and operated by the Waterford School District. The school serves children in grades K-12 who have been adjudicated via the Probate Court for delinquency, neglect, truancy at home/school, or incorrigibility at home/school. These students come from all 28 school districts in Oakland County, other counties within the State of Michigan and also some out-of-State students.

Mason Middle School formally invites parents to participate in a conference with teachers to share in a discussion on the progress of their child. We encourage parents to schedule conferences as needed throughout the school year to address any questions or concerns they have regarding academic or social emotional issues impacting their learning. While we strive for 100% participation, we are pleased to share that our teachers conferred with over 1700 families about the progress made by their child during our parent teacher conferences for the last two school years. For the 2016-17 school year, we had 73% participation. For the 2017-18 school year, participation was at 69%.

Mason Middle School strives to inspire, educate and empower our students for their

future in all academic and personal endeavors. While we are pleased with the progress we have made as a community of learners and the individual growth each of our students has made, we are still working tirelessly to improve and ensure

success for all students. Our staff is committed to working collaboratively in professional learning communities to ensure a quality experience for all children.
