TOPIC: Resolution: Celebrating the 100th Anniversary of the Ratification of the 19th Amendment to the US Constitution, Giving women the right to vote.

It is recommended that the board approve the following resolution:

CELEBRATING THE 100TH ANNIVERSARY OF THE RATIFICATION OF THE 19TH AMENDMENT OF THE US CONSTITUTION, GIVING WOMEN THE RIGHT TO VOTE

WHEREAS women of every race, class, and ethnic background across America have made historic contributions to the growth and strength of the United States in countless recorded and unrecorded ways; and

WHEREAS the women of this nation initiated the most significant women's movement in history – the need for women's suffrage; and

WHEREAS despite the strong opposition, the inspiration and determination of women nationwide brought about the extraordinary accomplishment – the right for women to vote; and

WHEREAS on June 10, 1919, Michigan women cast their vote when Michigan voters ratified the 19th Amendment to the U.S. Constitution, and

WHEREAS the State of Michigan was the second state to ratify the 19th Amendment, giving women the right to vote; and

WHEREAS on August 26, 1920, voters across the nation secured the right for women to vote when the 19th Amendment to the Constitution of the United States was ratified, empowering American women and declaring for the first time that they, like men, deserve all the rights and responsibilities of citizenship stating, "...the right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex"; and

WHEREAS August 26, 2020 will mark the 100th anniversary of the passage of the National Suffrage Amendment, the 19th Amendment to the U.S. Constitution, guaranteeing women the right to vote; and

NOW THEREFORE BE IT RESOLVED that the Waterford School District remembers and celebrates the historic women who fought for their right to vote and recognizes the courage and inspiration of these bold women to change the course of history.

BE IT FURTHER RESOLVED that the Waterford School District will fly the 19th Amendment Victory Flag June 10, 2019 through June 14, 2019 to commemorate the State of Michigan ratifying the 19th Amendment and August 24, 2020 through August 28, 2020 to commemorate the ratification of the 19th Amendment to the Constitution of the United States.

Per the discussion at our previous Board of Education meeting, draft policy language has been developed for the Board to consider.

New language has been added to Policy 5850 – Social Events. The new language is in bold and caps.

5850 - SOCIAL EVENTS

The Board of Education recognizes the value of student social events in enhancing and enriching the educational experience for the children of this community.

The Board will make school facilities available and provide appropriate staff for the conduct of social events within the school facilities which have been approved by the appropriate administrator.

School social events which take place outside school facilities must be approved by appropriate administrator.

As voluntary participants in school social events, students shall be held responsible for compliance with the rules set forth for their conduct, and infractions of those rules will be subject to the same disciplinary measures applicable during the regular school program.

Participation in school events is not a right and may be denied to any student who has demonstrated disregard for the rules of the school.

The Superintendent shall develop administrative guidelines for the conduct of student social events which shall include:

- A. designation of a staff member who shall be the employee responsible for the event;
- provision for chaperonage, adult supervision, and/or police protection required by the circumstances of the event;
- C. provisions for the safety of all students and adults involved.

ALL NIGHT GRADUATION PARTIES (ANGP)

THE FOLLOWING REQUIREMENTS ARE DIRECTED TO THE COMMITTEES THAT INITIATE AND IMPLEMENT ALL NIGHT GRADUATION PARTIES FOR WATERFORD SCHOOL DISTRICT HIGH SCHOOLS:

- BUILDING ADMINISTRATORS WILL APPROVE ALL ANGP.
- IT IS REQUIRED THAT A MINIMUM OF TWO WATERFORD POLICE DEPARTMENT OFFICERS BE ON DUTY AT ALL TIMES DURING THE ANGP. IF USING A VENUE OUTSIDE OF WATERFORD TOWNSHIP IT IS EXPECTED THE ANGP COMMITTEE WOULD CONTRACT WITH THE POLICE DEPARTMENT OF THAT CITY OR TOWNSHIP.

 - o DISTRICT FACILITIES ARE NOT USED FOR ANGP FUND RAISING.
 - THE ANGP IS CONSIDERED A NON-SCHOOL-SPONSORED EVENT.
 - THE ANGP DOES NOT FALL UNDER ANY SCHOOL DISTRICT INSURANCE PROTECTION.
