

OTHER CONSIDERATIONS:

Although VJM was the apparent low bidder for the Kettering Core Area project, we **do not** recommend that VJM be awarded the project for these reasons:

- 1. Typically the crews are small have resulted in going past the deadline for allowed working days before school is in session.
- 2. Unsatisfactory Safety Record.
- 3. Using untrained staff that had not been on a roof before.
- 4. Poor detailing.
- 5. Leaving the roof open with no temporary tie-ins, resulting in flooding the school at least twice.
- 6. Damaged sidewalks and sod that was not restored.
- 7. During moving insulation, a crew member fell off the roof and was severely injured.

These items, and others not documented here, do not represent safe or professional work practices. Thus, SME recommends to not award to VJM.
